
CERTIFICATE OF TRUSTEES


This undersigned, John C. Anderson, Marc Favreau, and Graham Houghton, having personal knowledge of the facts herein stated, under oath, certify as follows:

1. The Skiffs Northern Plains Trust (the "Trust") was established by Declaration of Trust dated March 11, 1990, and recorded with the Dukes County Registry of Deeds in Book 537, Page 752.
2. The Trust was thereafter amended and restated in its entirety by instrument dated March 7, 2011, executed by Michael McCormack, Julie A. Robinson, and John C. Anderson, as trustees, and recorded with the Dukes County Registry of Deeds in Book 1241, Page 602, and filed with the Dukes County Registry District of the Land Court as Document No. 73289.
3. Michael McCormack and Julie Robinson have resigned as trustees of the Trust, effective as of August 9, 2025.
4. Pursuant to the Trust and by the appointment of not less than two-thirds (2/3) of the beneficiaries of the Trust, Marc Favreau and Graham Houghton have been duly appointed as successor trustees of the Trust, effective as of December 13, 2025.
5. John C. Anderson continues to serve as a trustee of the Trust and has not resigned.
6. As of the date hereof, the duly appointed, qualified, and acting Trustees of the Trust are John C. Anderson, Marc Favreau, and Graham Houghton.
7. The Trust is in full force and effect and has not been revoked or terminated as of the date hereof, and has not been altered, amended, or modified except as set forth herein.
8. This Certificate is executed for the purpose of giving notice of the foregoing resignations and appointments of trustees and may be relied upon conclusively by all persons without further inquiry. No person dealing with the trustees shall be required to inquire into the existence, validity, or scope of their authority or the application of trust assets.


